

**AMENDMENT NO. 2 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
ROBERT HALF INTERNATIONAL INC.
FOR
STAFFING AUGMENTATION**

RESOLUTION NUMBER:

This **Amendment No.2** (“Amendment”) is made by and between the City of San Leandro (“City”) and Robert Half International Inc. (“Consultant”) (together sometimes referred to as the “Parties”) as of, March 20, 2023 and amends that certain Consulting Services Agreement (“Agreement”) dated March 10, 2022, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to staffing augmentation and

WHEREAS, the Parties desire to amend the Agreement to reflect an extension of the Term and a new maximum amount of compensation of \$370,000.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled “Term of Services” is hereby amended to extend the term from April 30, 2024 to June 30, 2024; and
2. Section 2 of the Agreement entitled “Compensation” is hereby amended to pay Consultant a sum not to exceed \$370,000; and
3. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
