Background

- Council Goal Place City on firm foundation for long-term fiscal sustainability
- User fees and service charges:
 - Reviewed during budget process
 - May only recover the cost of the service
 - Change in the local consumer price indices
- Taxes adjusted by Consumer Price Index (CPI) as per Municipal Code
 - Business License, 911, Emergency Medical Services (EMS) adjusted by 2.6% CPI
- Proposed adjustments are effective July 1, 2016

Background (cont.)

- Fees and taxes adjusted annually according to CPI
- Revenues are used for general City Services:
 - Safety Police and Fire
 - Dispatch, Code Enforcement, Protection, Hazardous spill clean-ups
 - Community programs Library and Recreation services
 - Reading programs, Swimming programs, Family programs
 - Community infrastructure Public Works and Engineering and Transportation
 - Potholes, sidewalks, median landscape maintenance, park landscape maintenance, Graffiti removal
