Diesel engines in vehicles of all sizes in CA require clean-air exhaust systems.

Standard Business Process:

DES employees bring a vehicle into the shop, connect a computer to the system and diagnose any issues listed for the emissions system: normally high back pressure in the exhuast. They would remove the components from the exhaust system of the diesel engine and test them for the correct performance range on a test bench. Components would be replaced with new or the originals would be conditioned for reuse if the test approved them for reuse. Conditioning and reruse is the most common out come of the tests. Defective components found during the troubleshooting would be replaced with new components. The system would be reisntalled with new gaskets, tested for leaks and proper operation. In addition to servicing, occationally new retrofit systems would be installed on engines that require the systems to continue to operate in California in accordance with regulations. The entire process follows California Air Resources Board and manufacturer required guidelines.

The intent of this operation is not to be a full service truck or vehcile repair facility but to specialize in the selling, servicing, and support for clean diesel aftertreatment systems. However, we understand that due to the broad nature of The City zoning rules the scope of our work falls under the definitions

assigned to vehicle repair facilities. Therefore we are applying for Conditional Use Permit for the items listed below.

The site address (1471 Doolittle Dr San Leandro) is in a business park that is designed for heavy-duty diesel truck operation on a regular basic. All the buildings in the business park have loading docs for semi-trucks and trailers. Existing traffic flow will be the same as the proposed business.

Parking of vehicles outside the building will be done in existing vehicle parking locations. A fence will not be installed around any of the spaces or in the yard area. The business will not be advertising nor encouraging storage of vehicles or equipment. The permit for Vehicle Storage is only requested as directed by City permit staff as a necessary requirement of any vehicle repair facility within San Leandro limits.

#### Conditional Use Permit Zoning Codes Requested

After review of the zoning codes with The City, and comparing it to the full scope of our business, it appears that our business requires approval for four separate sections under the conditional permit regulation. As per San Leandro Zoning Code 2-706 B.4, 27, 28, and 31 listed below.

**Corporation Yards. (2-706 B.4)** Facilities providing maintenance and repair services for vehicles and equipment, and materials storage areas. This classification includes equipment maintenance and service centers and similar facilities.

**Vehicle/Equipment Repair, General. (2-706 B.27)** Repair of large commercial trucks [over six (6) wheels or over ten thousand (10,000) pounds], mobile homes, recreational vehicles or boats, including the sale, installation, and servicing of related equipment and parts.

Vehicle/Equipment Repair, Limited. (2-706 B.28) Repair of automobiles, small trucks (e.g., pickup trucks), or motorcycles, including the sale, installation, and servicing of related equipment and parts. This classification includes auto repair shops, body and fender shops, wheel and brake shops, stereo installation, and tire sales and installations, but excludes vehicle dismantling or salvage and tire re-treading or recapping.

**Vehicle Storage**. **(2-706 B.31)** Storage of operative or inoperative vehicles. This classification includes storage of parking tow-away, impound yards, storage lots for automobiles, trucks, buses, recreational vehicles, and boats, including re-occurring storage of trucks as an "off-site" annex facility, but does not include "parking lots" or vehicle dismantling.

**Description of building and site:** Site 1471 Doolittle Drive is a multi-tenant concrete tilt-up building situated in a business park of similar adjacent building of varying size.
