

**AMENDMENT NO. 2 TO NON-PROFESSIONAL SERVICES AGREEMENT BETWEEN  
THE CITY OF SAN LEANDRO AND  
MV TRANSPORTATION, INC.  
FOR  
PARATRANSIT TRANSPORTATION SERVICES**

This **Amendment No. 2** ("Amendment") is made by and between the City of San Leandro ("City") and MV Transportation, Inc. ("Contractor") (together sometimes referred to as the "Parties") as of June 28, 2018, and amends that certain Non-Professional Services Agreement ("Agreement") dated November 1, 2016, between the Parties.

**WHEREAS**, City and Contractor have executed the Agreement, pursuant to which Consultant has provided certain contract services to City with regard to providing paratransit transportation services to eligible senior citizens and people with disabilities; and

**WHEREAS**, Contractor has successfully fulfilled contractual agreement for the past year without an increase in unit costs; and

**WHEREAS**, the Parties desire to amend the Agreement to extend the Term of Services from July 1, 2018 to September 30, 2018.

**NOW THEREFORE**, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from November 1, 2016 to September 30, 2018; and
2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Contractor a sum not to exceed Four Hundred Sixty Eight Thousand, Three Hundred Eighty (\$468,380); and
3. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to add Compensation Schedule for FY 2017-18 as attached hereto and incorporated herein by reference; and
4. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.


