CONSTITUENTS OF DISTRICT 4, REPRESENTED BY COUNCIL MEMBER BENNY LEE, REQUEST URGENT ATTENTION AND CONSIDERATION OF THE FOLLOWING TRAFFIC ISSUES ON LEWELLING BLVD:

## **1. EXCESSIVE SPEEDING**

- 2. EXCESSIVE NOISE
- 3. LACK OF TRAFFIC CALMING MECHANISMS
- 4. PEDESTRIAN DANGER
- 5. PROPERTY DAMAGE

6. POTENTIAL LIABILITY TO THE CITY FOR FAILURE TO RESPOND TO A KNOWN HAZARD

CONSTITUENTS REFER SPECIFICALLY TO LEWELLING BLVD BETWEEN WASHINGTON AVE AND WICKS BLVD. THIS IS A 4 LANE, EAST-WEST ARTERIAL CONNECTOR WITH A POSTED SPEED OF 40MPH.

THE STRETCH OF ROAD IS 1.3 MILES. THERE IS ONE TRAFFIC LIGHT IN THIS SEGMENT AT FARNSWORTH. THE ROADWAY IS PRIMARILY STRAIGHT.

A LANDSCAPED MEDIAN RESTRICTS CROSS TRAFFIC TO 4 INTERSECTIONS. CROSSWALKS ARE PAINTED AT 5 INTERSECTIONS, WITH ANDOVER STREET HAVING THE SOLE LIGHTED PEDESTRIAN CROSSING SIGN. WOODROE WOODS ELEMENTARY SCHOOL BACKS DIRECTLY TO LEWELLING. A CHURCH IS LOCATED ON LEWELLING ACROSS LEWELLING FROM THE SCHOOL.

THESE CONDITIONS PROVIDE A RIPE OPPORTUNITY FOR EXCESSIVE SPEEDING, AND THE DUAL LANES ARE IDEAL FOR RACING. THE ROAD SEGMENT CONTINUES TOO LONG BEFORE A TRAFFIC REGULATING MECHANISM SLOWS OR STOPS VEHICLES.
