# **6.b.** 24-003 Continued Review of Racial and Identity Profiling Act (RIPA) Data and Development of Related Recommendations

Moved by Member Bob Bailey, seconded by Member Keith Gibbs, that the Community Police Review Board (CRPB) is concerned about the racial disparities in the San Leandro Police Department (SLPD) Racial and Identity Profiling Act (RIPA) data as reported by the Independent Police Auditor (IPA), and wants assurances that SLPD considers means to reduce such racial disparities; accordingly, the CPRB requests that SLPD and IPA report back to the CPRB as soon as practical with further data analysis on the frequency of non-compliance with the reporting requirements; frequency of improper stops; a comparison of the outcomes by race for the 7 stop categories; and a month to month comparison of 2023 versus 2024.
