<u>Draft Zoning Code Amendments_PC 061616</u>

Principal Planner Sally Barros presented on the proposed Zoning Code amendments related to the Draft General Plan. Due to potential conflict of interests (related to place of work and/or potential business interests) for the proposed re-zoning in certain districts, the following commissioners recused

themselves from the following segmented presentations: Downtown North (Commissioner Pon), Downtown West (Chair Hernandez & Vice Chair Hussey), and Marina East (Vice Chair Hussey). Commissioner Pon made a motion, seconded by Commissioner Coller, to nominate Commissioner Abero as temporary chair during the Downtown West presentation. The motion was approved 3 Aye, O No, and 1 Abstain (Abero).

There were 20 public comments on the proposed Zoning Code amendments. Karen Diaz (655 Broadmoor) commented during the Downtown West zoning changes that the proposed increased density in that zoning district seemed to high. Jamie Santos commented on the Marina West zoning changes that she was concerned about compliance with future zoning changes in the area.

Sixteen (16) of the public commenters opposed the proposed Downtown East zoning changes because they were too dense and beyond the downtown transit-oriented development boundary, and would bring negative impacts like increased traffic: Peggy Martin (923 Bancroft Ave), Phil Daly (957 Bridge Road), Aaron Brown (958 Bridge Road), Susan Rose Riskind (182 Sunnyside Drive), Jeanne Kinkella (837 Joaquin Ave), Maureen Forney (941 Bridge Road), Lola Sander (678 Joaquin Ave), Mia Ousley (738 Victoria Ave), Dori Gutman (971 Bridge Road), Alex Dolan (949 Begier Ave), Margaret Carlson (721 Joaquin Ave), John Carlson (721 Joaquin Ave), Stephen Cassidy, Karen Diaz, Vanessa Pineda-Klein (1138 Begier Ave), and Bahar Navab (901 Bancroft Ave). Addiitionally, Tom Silva (Hayward) commented as developer of the proposed 1300 Bancroft mixed use development. and invited the public to attend a tour with him of his proposed site and Darlene Evans (361 Bristol Blvd) also commented.
