A. Oral Commissioner Park Visit Reports

- Commissioner Zuber observed a large tree branch leaning against a tree at Memorial Park, as well as gum in the drinking fountain. Zuber also commented on the lack of stall doors in the restrooms. Commissioner Shapiro also commented on Memorial Park, stating the walkway from Bancroft Avenue was littered with trash, but the playgrounds were well-kept. Shapiro also noted that at Memorial Park, a number of parents sit in the cars while their children play.
- Commissioner Udemezue noticed the construction progressing at Siempre Verde Park and Udemezue commented that Root Park looked clean at the time of his visit.
- Commissioner Bolar visited Cherry Grove Park and Washington Manor Park. Bolar reported some playground maintenance issues from Cherry Grove and commented that the tai chi space at Washington Manor Park looked nice, but did not appear to be well used.
- Commissioner Wagner reported that the dog park was in good condition and the weeds near the fence were not causing issues.

B. Oral Park and Open Space Operations and Maintenance Update

- Play equipment will be painted at the north playground of Marina Park and new rubber surfacing will be replaced in a portion of the playground.
- The annual shoreline cleanup will take place on Saturday, September 17, 2016.

- The shade structure purchased for Area 1 at Washington Manor Park will be installed in the near future.
- A Kaboom! community playground build will take place at Grover Cleveland Park.

### **ORAL REPORT OF SECRETARY**

- A. Recreation and Human Services Calendar of Meetings and Events
- Kiddie Kollege preschool programs began on September 6<sup>th</sup>. A lead teacher is needed for the class held at Washington Manor Park.
  - The San Leandro Moon Festival will be held on September 11 at Marina Park. The BikeMobile will also be at Marina Park on the 11<sup>th</sup> to service bikes.
  - Gail Goldman, Public Art Master Plan Consultant, will be attending the September 14 meeting of the Arts Commission.
  - Diabetes and Wellness Day will be held at the San Leandro Senior Community Center on September 17, 2016.
- B. Oral Update on Current Projects
- Secretary Donnelly reported that the Recreation and Human Services Department is working with a start-up, LotaData to develop an app to gather data and push out department information. This project was funded by a Startup in Residence (STIR) grant. Donnelly will try to arrange a demonstration of the data collection for the October meeting.
  - Secretary Donnelly provided additional information on the Kaboom! community playground build at Grover Cleveland Park. The project is being funded by a corporate partner and community partner. Donnelly reported that the design meetings were taking place on Wednesday, September 7 and the build would take place on Friday, November 4. Donnelly requested Commissioners save the date for the build and asked if Commissioners were interested in taking on a larger role in the event. Commissioner Shapiro asked about school and high school involvement in the build day.
  - Donnelly provided Commissioners with an update on the Recreation and Human Services employment vacancies.

Secretary Donnelly proposed taking elements of the Bike Party and incorporating them with the Siempre Verde Park Rededication event.

- Secretary Donnelly shared the event flow with commissioners, as well as marketing and outreach efforts.
