## 6. ORAL REPORT OF SECRETARY

6.A. Alameda County Homeless Summit

EveryOneHome is an organization that coordinates homelessness in Alameda County The data presented shows a snapshot of the state of homelessness in Alameda County and does not fully reflect the state of homelessness in San Leandro. San Leandro has more homeless population than listed on the report. The data affected one specific grant that used the data to determine appropriation.

Commissioner Sarafian inquired how many beds we provide in San Leandro. We have no shelters in San Leandro.

Commissioner Sanchez inquired what EveryOneHome does and if the City can still affect the count. They are an organization in San Leandro that is part of a County agency, with reputable work in homelessness policy and advocacy. At this point, the data count cannot be affected anymore. Secretary Dong has attempted to have the data corrected, however she was informed that the data presented is final for this year. The data is considered a point-in-time count for the entire county and other cities are also undercounted.

#### 8.A. Presentation from CALICO (E. Harper - 15 minutes)

Brings together law enforcement officers, child welfare workers, prosecutors, and other professionals to investigate abuse allegations and elicit testimony from children.

Uses a nationally proven method designed to attain thorough and accurate information while protecting the emotional needs of the victim. One of only twenty-one centers in California that are nationally accredited.

Children are interviewed in a child friendly environment and the interviews are coordinated which eliminates the need for multiple interviews that can be traumatizing for the subject.

Commissioner Snell clarified if interviews means a single case and inquired about the name of accrediting agency that CALICO is a part of Interviews does mean a single individual case, the agency is accredited by the National Children's Alliance.

Secretary Dong inquired how many of the caseload are repeats. Caseloads are not usually repeats. It is the organization's goal to only have one interview for the child.

Commissioner Naranjo inquired how confidentiality is maintained with the client. Copies of the interview are strictly controlled. Two DVD copies are made of interviews, one copy is given to the police department and another is kept by CALICO (stored in Fremont Police Department Evidence Locker). Chair Aguilar inquired how long the records are kept. CALICO keeps all records indefinitely.
