Item 9B was moved up in advance of 9A.

Secretary Engelbart and Vice Chair Gonchar provided an update on their efforts to identify alternative funding sources that could be used to support the Comedy in the Plaza event. Vice Chair Gonchar also requested that the Commission be provided a training on conflicts of interest regulations at a future meeting. Commissioner Copeland further outlined the vision for the event and requested that the alternative funding sources be confirmed with certainty as soon as possible.

MSC (Copeland/Guillory) to allocate \$150,000 towards the creation or procurement of a work of art to be installed at the Main Library, as well as \$50,000 towards the Arts & Culture grants program. (7 Ayes, 0 Nays, 2 Excused)
