6. ORAL REPORT OF SECRETARY

6.A. Warming Shelter

Secretary Castillo gave an update on the warming shelter: announced that shelter is continuing to recieve an average of 25 folks a night and is still welcoming volunteers to cook meals.

6.B. Alameda County Homeless Point-In-Time (PIT) Count

Secretary Castillo gave an update on the Homeless Point-In-Time Count: Volunteers and Homeless Guides reported to Hayward City Hall on January 30th at 4:45am. The recruited volunteers and city staff were successful in recieving deployments within the City of San Leandro. Digitized census maps were marked with known encampments and were distributed to all volunteers to ensure a more accurate count in comparison with the 2017 undercount of 300 percent. Based on volunteer reported numbers, it is estimated that there are over 300 homeless in San Leandro. Final count will be known August 2019.

6.C. Community Assistance Program (CAP) site visits

Secretary Castillo announced that site visits to C.A.P. funded organizations would begin in late March through the end of April and circulated a sign-up sheet for commissioners to indicate which sites they were interested in visiting.

Commissioner Snell requested commissioners be provdied with assessment forms during their visits.

8.A. Presentation on Harambee Community Services - Denise Bradley

Harambee Community Services is a specialized Adult Day Program that provides community-based services to adults with intellectual disabilites. The organization provides vocational, social, recreational, leisure, community and independent living skill development to participants who have intellectual (mental retardation), developmental disabilities (autisim, cerebral palsy), behaviorial and mental health challenges. The organization supports participants in maximizing their ability to enjoy life.
