RESOLUTION of the City of San Leandro City Council to Accept the Engineer's Report for Fiscal Year 2021-2022 for the Heron Bay Maintenance Assessment District, Assessment District No. 96-3 (Provides funding for the on-going maintenance of certain public facilities constructed as part of the Heron Bay Development)

WHEREAS, the the City of San Leandro City Council, pursuant to the provisions of San Leandro Municipal Code § 2-5-100 et seq. did order the Engineer, Willdan Financial Services, to prepare and file a report in accordance with the Municipal Code in connection with the proposed levy and collection of assessments for the district known and designated as the Heron Bay Maintenance Assessment District (Assessment District No. 96-3) for the fiscal year commencing July 1, 2021 and ending June 30, 2022; and

WHEREAS, the Engineer prepared and filed with the City Clerk of the City of San Leandro, and the City Clerk presented to the City Council such report entitled "Engineer's Report, Heron Bay Maintenance Assessment District, Assessment District No. 96-3, 2021/2022 Engineer's Annual Levy Report" (hereafter referred to as the "Report", attached hereto and made a part hereof); and
