WHEREAS, CDBG public services agreements between the City of San Leandro and Building Futures With Women and Children (BFWC) - San Leandro Shelter; Davis Street Family Resource Center (DSFRC) for Basic Needs Program and Community Counseling Program; Eden Council for Hope and Opportunity (ECHO Housing) for tenant-landlord counseling services and Rental Assistance Program; Girls Incorporated of Alameda County (Girls Inc.); Safe Alternatives to Violent Environments (SAVE); and Service Opportunity for Seniors, Inc. (SOS), copies of which are attached, have been presented to this Council; and

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager has recommended the approval of said agreements.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as follows:

That said agreements are hereby approved and execution thereof is hereby authorized for the CDBG public services grant amounts of \$14,718 for BFWC's San Leandro Shelter; \$24,530 for DSFRC Basic Needs Program; \$7,008 for DSFRC Community Counseling Program; \$10,512 for ECHO Housing's tenant-landlord services; \$5,000 for ECHO Housing's Rental Assistance Program; \$7,008 for Girls Inc.; \$7,667 for SAVE; and \$7,667 for SOS.
