# SUMMARY

The California State Library's Building Forward match grant is a never-before-seen opportunity to fund library construction projects in the state of California. \$439 million was made available by the Budget Act of 2021 (SB 129) in one-time grants to address life-safety and critical maintenance needs of public library facilities throughout California. The maximum grant amount for this competitive grant program was \$10 million per public library building. The state received 275 applications. Requests exceeded \$1.1 billion.

San Leandro Public Library applied for the Building Forward match grant, requesting \$4,597,100 for the Mulford-Marina Branch Library Improvements project. The Library was awarded \$4,079,701.

# RECOMMENDATIONS

Staff recommends the City Council adopt a resolution that authorizes the submission of the application, approval to implement the awarded project, and to accept the grant award totaling \$4,079,701 from Building Forward match grant and authorize the City Manager to execute all documents and appropriate the funds.

### BACKGROUND

As part of the original Shoreline Development project, an upgraded replacement Mulford-Marina Library facility was part of the plan. For roughly 20 years, there were various attempts to replace this aging facility that was originally built in 1976. Unfortunately, funding for the project did not materialize. This match grant, along with the dedicated funding the City Council has allocated to not only match the grant but exceed the match to cover expenses that the grant does not, will complete this long-awaited project.

#### <u>Analysis</u>

For FY 2022-2023, the award letter (Attachment B) provides \$4,079,701 in match grant funds for the Mulford-Marina Branch Library Improvements project. Match funds are subject to the same restrictions as the grant funds and may not be spent on any unallowable costs (see Attachment C), and match funds must be spent during the grant period (no later than March 31, 2026) at the same rate as grant funds.

The grant is governed by the Grant Agreement & Certification of Compliance. A draft of the Grant Agreement & Certification of Compliance has been provided (Attachment D). The City will receive the official Grant Agreement & Certification of Compliance through DocuSign after a resolution approving acceptance of the grant has been executed.

The San Leandro Public Library will receive \$2,039,851 of the award following the submission and approval of all required documents including a resolution accepting the grant award. The second payment in the amount of \$1,631,880 will be made after the submission and approval of the January 31, 2024 report, or sooner with proof of funding. The final payment of \$407,970 will be made upon submission and approval of the final interim grant report and financial claim form.

## Legal Analysis

The City Attorney has reviewed these documents and agreements and approves them as to form.

#### Financial Impacts

Sufficient funds are included in the CIP Budget to facilitate the match requirements of this grant. Acceptance of this grant does not impact the Fiscal Year 2022-2023 General Fund budget. State grant funding for FY 2022-2023, FY 2023-2024, and a future fiscal year, if necessary, will be awarded upfront and deposited into the 150-3607 Revenue Account and expended as follows:

This Council action will not impact fund balance because there are funds available in the FY 2022-2023 CIP adopted budget. Furthermore, grant funds will be awarded up front and expended in the same year they are awarded. In future fiscal years (up to FY 2025-2026 with grant period ending March 31, 2026), the remainder of the grant totaling \$407,970 is 10% of the grant total and will be held by the grantor as a reimbursement style grant and payable to the City upon completion of final reporting and claims forms.
