WHEREAS, CDBG public services agreements between the City of San Leandro and Child Abuse Listening, Interviewing, and Coordination Center (CALICO); Davis Street Family Resource Center (Davis Street); Service Opportunities for Seniors, Inc. (SOS/Meals on Wheels); and Eden Council for Hope and Opportunity Housing (ECHO Housing), copies of which are attached, have been presented to the City Council; and

WHEREAS, the City Council is familiar with the contents thereof; and

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as follows:

That said agreements are hereby approved and execution thereof is hereby authorized for the CDBG public services grant amounts of \$20,537 for CALICO; \$36,197 for Davis Street; \$42,203 for SOS/Meals on Wheels; and \$10,000 for ECHO Housing fair housing services, as provided in the

associated staff report.
