RESOLUTION of the City of San Leandro City Council to Approve Community Development Block Grant (CDBG) Agreements for FY 2021-2022 Between the City of San Leandro and CDBG Sub-Recipients for Public Services Grants to the Child Abuse Listening, Interviewing, and Coordination Center (CALICO) for \$23,344; Davis Street Family Resource Center for \$35,000; Service Opportunities for Seniors, Inc. (SOS/Meals On Wheels) for \$35,000; Spectrum Community Services (San Leandro Senior Nutrition Program) for \$24,909; (ECHO Housing) for \$10,000 (Approves 5 Agreements Totaling \$128,253)

WHEREAS, the final Annual Action Plan (referred to hereinafter as “the Plan”) was adopted on May 3, 2021 by Resolution No. 2021-065 reflecting the activities that the City plans to fund and implement during FY 2021-2022, a copy of which is attached hereto; and

WHEREAS, CDBG public services agreements between the City of San Leandro and Child Abuse Listening, Interviewing, and Coordination Center (CALICO); Davis Street Family Resource Center; Service Opportunities for Seniors, Inc. (SOS/ Meals on Wheels); Spectrum Community Services (San Leandro Senior Nutrition Program); and Eden Council for Hope and Opportunity Housing (ECHO Housing) are presented to the City Council; and

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager recommends approval of said agreements.

NOW, THEREFORE, the City Council of the City of San Leandro RESOLVES as follows:

That said agreements are hereby approved and execution thereof is hereby authorized for the CDBG public services grant amounts of \$23,344 for CALICO; \$35,000 for Davis Street Family Resource Center; \$35,000 for SOS/Meals on Wheels; \$24,909 for Spectrum Community Services; and \$10,000 for ECHO Housing fair housing services, as further provided in the associated staff report.
