WHEREAS, the City Manager also recommends that General Fund economic uncertainty reserves should be used for the design and installation of a Free, Public Wireless Network in Downtown San Leandro.

That said agreements with SmartWAVE Technologies in the amount of \$30,416.00 and Pelton Plaza in the amount of \$37,974.00 are hereby approved and execution by the City Manager is hereby

That an appropriation of funds in the total amount of \$68,390.00 from General Fund economic uncertainty reserves to the Business Development Budget (Account 010-41-003) for \$37,974.00 and to the IT Operating Budget (Account 688-13-121) for \$30,416.00 is hereby authorized, to cover the costs of design and installation of a Free, Public Wireless Network in Downtown San Leandro.
