WHEREAS, a previous Administering Agency-State Agreement No. 04-5041R for Federal Aid was entered into between the City of San Leandro and the State of California on February 22, 2007; and

WHEREAS, the Administering Agency-State Agreement has been updated to incorporate various changes in regulations and policies; and

WHEREAS, the City has been awarded a \$254,405 Highway Safety Improvement Program Grant and must execute the Administering Agency-State Agreement and the Program Supplement Agreement to receive the funds; and

WHEREAS, Administering Agency-State Agreement No. 04-5041F15 and Program Supplement Agreement No. 025-F between the City of San Leandro and the State of California has been presented to this City Council; and

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager recommends approval of said agreement.
