**WHEREAS**, an agreement between the City of San Leandro and Lee & Ro, Inc., a copy of which is attached, was presented to this City Council; and

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager recommends approval of said agreement.

**NOW, THEREFORE**, the City Council of the City of San Leandro does **RESOLVE** as follows:

- That said agreement is hereby approved and execution by the City Manager is hereby authorized; and
- That the City Manager or his designee is authorized to negotiate and approve an amendment of up to 10% (or \$19,617) of the original contract amount; and
- That \$265,790 of Water Pollution Control Plant Enterprise fund balance be appropriated to the project as follows: Account No. 593-52-250-4000 \$50,003 for staff time; Account No. 593-52-

250-5120 \$196,170 for the Lee & Ro agreement; and Account No. 593-52-250-5120 \$19,617 for change orders.
