San Leandro Emergency Services

- Within the city, there have been 16,682 cases, 81,021 are partially vaccinated (91%), 76,497 are fully vaccinated (86%), and 65% have received a booster.
- Catrina has completed the Hazard Mitigation Grant (HMG) in order to hire a contractor to write the Local Hazard Mitigation Plan (LHMP)
- Assisting the Library with a fire drill and PW with development of Department Operations Center (DOC) to be used during an EOC activation.
- The City received a grant from ALCO OES for installing emergency generator hook-ups at MCC.
- The Adverse Weather Annex is nearing completion and will be available for peer review.
- PSPS events could still occur, though PG&E notified the City that do to system upgrades, the impact will be minimal, and the generator will not be located at the main library this summer, though the hook-ups will remain
