

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
W-TRANS
FOR
ON-CALL TRANSPORTATION ENGINEERING CONSULTING SERVICES**

This **Amendment No. 1** ("Amendment") is made by and between the City of San Leandro ("City") and W-Trans ("Consultant") (together sometimes referred to as the "Parties") as of _____, 2026, and amends that certain Consulting Services Agreement ("CSA" or "Agreement") dated July 1, 2023, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to on-call transportation engineering consulting services, and

WHEREAS, the Parties desire to amend the Agreement to extend the end date of the agreement.

WHEREAS, the CSA was approved by the Council on June 5, 2023, per Council Resolution Number 2023-059.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from June 30, 2026, to June 30, 2028; and
2. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read:

* Mileage charge will be based on the IRS Standard Mileage Rate (set at \$0.725/mile effective January 1, 2026) plus 10 percent.

3. Except as modified by this Amendment, all other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
