

**AMENDMENT NO. 2 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
CSG CONSULTANTS, INC.
FOR
ON-CALL CIVIL ENGINEERING AND LAND SURVEYING CONSULTING SERVICES**

This **Amendment No. 2** ("Amendment") is made by and between the City of San Leandro ("City") and CSG Consultants, Inc. ("Consultant") (together sometimes referred to as the "Parties") as of _____, 2026, and amends that certain Consulting Services Agreement ("Agreement") dated November 9, 2022, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to On-Call Civil Engineering and Land Surveying Consulting Services, and

WHEREAS, the Parties desire to amend the Agreement to increase the services the Consultant provides to the City.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from June 30, 2026, to June 30, 2027; and
2. Section 2. Compensation Amount is increased from \$300,000 to an amount not to exceed \$450,000; and
3. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended with a current "2026-2027 Fee Schedule" provided by the consultant on the next page.
4. Except as modified by this Amendment, all other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.

TERMS

- All hourly rates include overhead costs including but not limited to salaries, benefits, workers' compensation insurance, local travel, and miscellaneous office expenses.
- Overtime services and services provided outside of normal business hours will be billed at 1.5x the applicable hourly rate.
- On July 1 of each year following the contract start year, CSG will initiate an hourly rate increase based on change in CPI for the applicable region.
- CSG will mail/email an invoice every month for services rendered during the previous month. Unless otherwise agreed, payment terms are 30 days from receipt of invoice.
- This fee proposal is valid for a period of 90 days from date of submittal.
